CLEANING MALTA'S SEA

Grantee: Žibel

Duration: September 2023 - September 2024

Funds: €5,625

Malta's beaches and marine life are under siege from plastic pollution, a major threat to the health of our sea. Through MEF, Žibel hired their first paid staff member, enabling them to engage more people and businesses to clean Malta's marine environment. Through education and community engagement, Žibel aims to tackle marine litter and protect wildlife.

ABOUT ŽIBEL

Founded in 2017, the voluntary organisation Žibel raises awareness, inspires environmental action, and provides tangible solutions.

So far, Žibel has collected around 150,000 kg of waste from the Maltese environment, mobilized over 6,000 volunteers and 900+ divers, and retrieved more than 115 fishing nets from the seabed, saving thousands of sea creatures.

SHARK & RAY CONSERVATION

Grantee: Sharklab-Malta

Duration: February 2024 - February 2025

Grant: €4,300

Bull Rays are a critically endangered species which can be spotted along Malta's coast. Until now, very little scientific data has existed on the rays, resulting in a lack of clarity on the threats to this species. This project seeks to address the challenges faced by bull rays by publishing data collected by Sharklab-Malta over the past decade and lobbying for suitable conservation measures.

ABOUT SHARKLAB-MALTA

Sharklab-Malta is a voluntary organisation dedicated to supporting sharks and rays in Malta's waters through research, education and awareness raising.

This organisation is safeguarding Malta's marine life through initiatives such as egg acquisition from fish markets, reintroduction of rays into the sea, data collection and educational activities.

REGENERATING LANDSCAPES

Grantee: ACT

Duration: September 2023 - September 2024

Funds: €10,000

Malta's forest land cover stands at around 1%. The effects of climate change are manifesting in periods of scorching heat, which are further exacerbated in Malta's built-up regions. This project is contributing to the conservation of endemic flora. Given the right care, they can ensure the resilience needed to face climate change and safeguard Malta's wildlife and communities.

ABOUT ACT

ACT is on a mission to regenerate Malta's native flora through creative, community-driven approaches that promote awareness, positive involvement, and collaboration.

ACT's greenhouse is a space for conservation. It is also a space to allow people to connect with Malta's wildlife, learn about our natural heritage and engage with our communities.

SUPPORTING MALTA'S RANGERS

Grantee: Malta Ranger Unit (MRU)

Duration: February 2024 - February 2025

Grant: €9,500

Malta hosts around 170 bird species migrating between Europe and Africa, but poachers kill or capture up to 200,000 birds annually. Illegal trapping of birds also remains common. Limited enforcement allow these environmental offenses to continue. MEF is supporting MRU's conservation efforts by funding a patrolling vehicle. This critical addition enhances the Rangers' safety and efficiency, extending their reach and impact.

ABOUT MALTA RANGER UNIT

Malta Ranger Unit is the first NGO of its kind in Malta, which monitors all environmental illegalities under Maltese Law. The Unit has over 100 cases monthly and documents crimes such as illegal fishing, poaching of birds, illegal fires, littering, and dumping of waste. The MRU also focusses on educating the general Public, hence Rangers also offer school talks and CSR activities to increase knowledge about environmental legislation among the general public.

RIDE TO RECYCLE

Grantee: ROTA

Duration: July 2024 – July 2025

Funds: €5,000

Malta's air pollution levels are over twice the European average with the majority of pollution originating from cars. Monitoring stations across the island frequently report pollutant levels that surpass EU air quality standards, raising public health and environmental concerns. The Malta Environment Foundation is excited to be supporting Rota's initiative by facilitating the purchase of a cargo bike to collect batteries for recycling whilst also promoting sustainable transport.

ABOUT ROTA

Rota is a voluntary organisation advocating for safe bicycle use in Malta with an aim to represent all those who cycle or want to cycle in Malta.

They carry out lobbying to promote cycling to decision-makers, provide advice, educate about the principles of best practice by all road users, collaborate with groups who have similar interests and organise events to bring the cycling community together.

RENEWABLE ENERGY COMMUNITIES

Grantee: Friends of the Earth Malta

Duration: September 2024 - February 2025

Grant: €5,000

Nearly 90% of energy in Malta still comes from fossil fuel sources. Energy demand is projected to increase, and whilst investment in renewable energy has shifted some of that energy use to cleaner sources, the renewable energy transition is happening too slowly in Malta. MEF is excited to be supporting Friends of the Earth Malta in researching the practicalities of setting up renewable energy communities.

Friends of the Earth Malta campaign on the most pressing environmental and social issues, by engaging the public directly through a wide range of diverse projects and activities and mobilising people to participate in decision-making processes.
